As per the Decision of the National Executive and Council Decision, Digital Voting has been initiated.

- 1. The election will be held during the General Body Meeting on **7th March 2024 from 09:00am to 3:00pm** at Shri Ravji Jivraj Auditorium, Smt. Sunanda Pravin Gambhirchand Institute of Nursing and Para Medical Sciences, 338, RA Kidwai Road, Matunga, Mumbai-400019, Maharashtra.
- 2. The Provisional Ballot Paper is published solely for the information of the members.

- 3. Only Life Members of TNAI who are working or residing in Maharashtra are eligible to vote.
- 4.Members are requested to check their membership status at <a href="https://election.tnaionline.org/">https://election.tnaionline.org/</a>UpdateData/index.
- 5. If members are working or residing in Maharashtra but the verification of their membership status shows a different state, they can transfer their membership to Maharashtra using the above link. A copy of their residence or employment details should be attached for approval of the transfer.
- 6. No request for change of the status of membership (transfer of membership from any state branch to Maharashtra) will be permitted after 4:30 PM on March 3, 2024 till the election process is over.
- 7. All voters are requested to bring their TNAI Photo identity Membership card provided by the TNAI Headquarters. In case if the members have the old membership card are required to show any other photo identity (Election card/PAN card/Driving license,Adhar Card) before entering the hall for voting.
- 8. No one shall be allowed to vote before or after the scheduled time of voting.
- 9. Names of contestants who have not given their consent in writing to the Returning Officer will be deleted from the final Ballot Paper.
- 10. Each contestant is requested to submit the name of one representative (polling/counting agent) who can observe the entire voting process and counting process. The name of polling/counting agent should be submitted to the Returning Officer before 9 am on 7 March 2024. This shall be submitted in the prescribed form with name TNAI number of representative. Forms will be made available with returning officer.
- 11. No addition of contestant shall be made to the final ballot. Any contestant wishing to withdraw from any office should inform the returning officer at least 20 days before the election i.e. 17th February before 4:30 pm in writing to the following address:
